Recommendations

Elections Policy

20.03 Student Code of Conduct

- Automatic disqualification for those found violating the Student Code of Conduct

40.05 Election Committee

- EC members should be screened for conflicts of interest and should have no ties to the UWSA

110.03 Campaign Donations

- Sponsorships/donations should have a cap. It should match their campaign fund limitations (300 for Executives, 200 for Senate and 150 for Board of Directors) and any material items sponsored should be limited to that price range as well.

110.04 Videos and Apps

- Videos and apps should be charged at a higher percentage (changed to 20 or 30 percent instead of 10)

102.01 Submitting Complaints

- Complaints should not be able to be received after 48 hours of the unofficial election results being released.
- A complainant should not be able to make the same complaint more than once.
- Complaints need to include the specific violation they are referring to in their complaint.
- Complaint and Appeals form needs to be in the election policy

120.02 Investigating Complaints

- The 48-hour rule should be business days only. This would make it more convenient for the CRO, EC, candidates and members who are not always available during the weekends.

120.04 Cause for Penalty

- Need to be chosen and presented in the policy. Discretion of the CRO should be limited by having penalties chosen in the policy.

120.06 Disqualification

- Disqualification should include negative campaign tactics, violation of student code of conduct, misrepresentation of facts and persistent attempts to undermine the CRO or the EC to carry out their responsibilities

Include and Change:

- Change Policy 30.05 (4) to specify that this does not include missing or invalid signatures.
- Checking all nomination signatures takes time, and often takes the full 48 hours after the close of the nomination period. If the dates after nominations happen to be on weekends, the office is closed and students won't be able to hand in anything missing within the set 24 grace period.

Add:

- Once confirmed as a candidate, that is when the leave of absence starts. There is no set date when this is specified in the current election policy, and this leaves room for a grey area of when it should be.
- Election policy needs to include the material on slating and the campaign material sizes and limitations
- Restrictions on future running need to be set in place for those who do not take their posters down much later than the determined date.

Campaign Rules

- Section 70.02 subsection 10 of Unpaid Leave should include all employees of the UWSA, both paid and unpaid positions to maintain a standard of fairness in the elections.
- All positions of the UWSA (including board members) must resign their position if they wish to run for another position in the UWSA elections.
- Board of Directors or UWSA Members on Board should give class talks on election days encouraging the vote.

Society Elections

- Many new students are not well informed of the Election process. An Election Guide and Forms should be available to all Society's to better assist them in an Election for their Executive members and staff.
- All societies need to have a unified constitution that does not contradict the UWSA election policy.
